

## Section 1.7 of Fairfield Public Health Code

1.7 All license, permit, certificate, and plan review fees shall increase two percent each January 1st. The increased fees shall be rounded to the nearest whole dollar. An updated fee schedule shall be placed in the code each January 1st. Other fees shall be based upon costs and adjusted accordingly each January 1<sup>st</sup>.
